Therefore, any behaviour which is highly detrimental to this goal is not acceptable.

Cash

Unacceptable behaviour falls into, but is not limited by, the following categories and also extends to people who represent the club outside of the clubs facilities:

- 1. Foul, abusive or racist language.
- 2. Violent or reckless behaviour.
- 3. Behaviour damaging to club property.
- 4. Public nuisance.
- 5. Over intoxication.
- 6. General unlawful behaviour.

Under the Liquor Licensing Rules, the club can refuse to serve people who are considered intoxicated.

The club reserves the right to refuse service and to ask people to leave the clubs facilities if a person's behaviour becomes unacceptable in the club's view. Such occurrences, depending on severity are to be accompanied by the additional measure of a caution or a banning from the club and its facilities for an initial period of three (3) months. Persons who receive more than three (3) cautions in any twelve (12) month period will be automatically banned for twelve (12) months. Persons damaging club property will be asked to replace or repair any damaged club property.

In severe cases the committee reserves the right to ask offending persons to not represent the club or use any of its facilities until such time as a future committee sees fit to invite them back.

All judgements are to be made by the current committee within one month of the offense having been presented with all relevant information as is practically possible and notification given to the offender. Notification is to be presented by hand or by certified mail as deemed most
